The Biblical Queen Esther said, "for such a time as this." She had no idea when she became queen that she would be the instrument for saving the Chosen People from genocide.

When I founded the Ruth Institute in 2008, I did not realize where God would take this work. I thought I was going to be talking to college women about why they should be unafraid to embrace motherhood.

I had no idea I would become a campaign spokeswoman for man-woman marriage during the Proposition 8 Campaign in California. But I had enough research to know that kids need their parents and that their rights to those parents would be harmed if Prop. 8 failed. I couldn't sit on the sidelines while radicals redefined marriage and parenthood.

When we decided in 2013 to focus on the Survivors of the Sexual Revolution, we had no idea where that would lead. We just knew that millions of people had already been harmed by the Sexual Revolution and millions more were being seduced every day. No one was standing up for the victims. No one was helping them understand the connection between the toxic ideology of the Sexual Revolution and the pain they were enduring.

I had no idea we would be the ones to deal with sexual abuse, including clergy sexual abuse in the Catholic Church. But we are already tuned in to the needs of victims and survivors. Most of all, we are not afraid of dealing with every aspect of the Sexual Revolution.

When I hired Fr. Paul Sullins, I thought he was going to continue his sociological work on the impact of same sex parenting on children. I had no idea he was going to produce the most important statistical analysis of clergy sexual abuse in the Catholic Church.

I now feel I can say along with Queen Esther that, "for such a time as this," I founded the Ruth Institute. You will see from our activities this past year, that we have been in the middle of some of the most significant issues of our time. I feel sure that you will be proud to have been a part of this great adventure with us. And I hope you will continue to be part of our work.

NAMING THE PROBLEM: THE SEXUAL STATE

The Ruth Institute is building a global interfaith coalition to defend the family and build a civilization of love.

We oppose the Sexual Revolution because it has victimized millions of people. Up until now, these people have been socially invisible. Our strategy is to enlist, educate and encourage Survivors of the Sexual Revolution to become advocates for positive change. Together, we are creating a new cultural narrative around marriage, family and human sexuality.

This strategic vision guides all our on-going activities as well as our special projects and events.

DR. MORSE'S THE SEXUAL STATE: THE BLUEPRINT AND STRATEGIC ROADMAP

The Sexual Revolution is irrational and unsustainable, yet seductively appealing. Through its ideology, cultural elites have captured the power of the State to try to do the impossible: separate sex from babies, separate sex and babies from marriage, and wipe out all differences between men and women. The Sexual State: How Elite Ideologies are Destroying Lives and How the Church was Right All Along is Dr. Morse's analysis of the Sexual Revolution. It has been praised by activists, scholars and journalists alike.

Mike Huckabee Show On January 19, Dr. Morse discussed *The Sexual State* on the Mike Huckabee Show on the Trinity Broadcasting Network, the largest Christian broadcasting network in the country. Huckabee is the former Governor of Arkansas and twice candidate for the Republican Presidential nomination. Dr. Morse Speaks at Family Research Council On January 24, Dr. Morse spoke at the Family Research Council (FRC) in Washington, D.C., as part of its Speakers Series. FRC is one of America's foremost think tanks on issues impacting the family. FRC Senior Fellow for Policy Research, Peter Sprigg, introduced Morse. More than 100 Washington-based leaders and activists attended the forum. They enthusiastically embraced Dr. Morse's message. An FRC staff member said, "Dr. Morse described the Sexual Revolution as 'a totalitarian ideology that no Christian should get involved with.' Dr. Morse summed it up by saying, 'If you can make people call Bruce Jenner a woman, then you can make them do anything."



Outstanding Scholarship Award to Dr. Robert Gagnon, world-renowned Biblical scholar who thoroughly debunks "gay theology" in well-researched and thought-provoking works such as *The Bible and Homosexual Practice*: Texts and Hermeneutics. For his trouble, Dr. Gagnon no longer teaches at the Pittsburgh Theological Seminary, despite having served there with distinction for 22 years.

Activist of the Year Award to Mr. Jeff Morgan, a tireless proponent of divorce reform in Texas and beyond. An abandoned spouse and reluctantly divorced man himself, Jeff works with other Survivors to talk with legislators about reforming the unjust laws of unilateral divorce. Recently, Jeff was in the courtroom during the #SaveJames Younger case in Texas, where divorced parents are arguing over whether James is really a girl. Jeff interviewed the father. Without information like this coming out of the courtroom, no one would know about this tragic situation. Without the public outcry, poor James would be on his way to "transitioning" into a girl. We are so proud of Jeff Morgan, our go-getter Activist of the Year!

Public Witness of the Year Award to Ms. Moira Greyland for authoring her childhood memoirs, *The Last Closet: The Dark Side of Avalon.* Ms. Greyland is the daughter of bestselling science fiction author and feminist icon, Marion Zimmer Bradley, and famous numismatist Walter Breen. Her parents were unrepentant advocates for an unrestrained homosexual lifestyle. Moira's mother molested her. Moira caught her father molesting an 11-year-old boy and called the police. Her father died in prison. The rest of her family never forgave her. Ms. Greyland's speech was as brave and honest as her book.




Dr. Morse, Chris Brennan, Al Chlupacek, and Jeff Morgan during the Divorce Reform Panel

RESEARCH AND COMMENTARY ON SEXUAL ABUSE

When we first began talking about the Survivors of the Sexual Revolution in 2013, we considered including victims of sexual abuse but decided against it. The topic was troubling and disturbing. The rise of the #MeToo movement and the renewed attention to clergy sexual abuse in the Catholic Church made us realize we couldn't sidestep it any longer. The poisonous worldview of the Sexual Revolution provides "cover" for abusers. It also disarms the victims. We had to take a stand.

Dr. Morse has written extensively about the subject, especially in her regular column at the National Catholic Register. Several episodes of "The Dr. J Show" also deal with this topic. The response from sexual abuse survivors tells us that dealing with this difficult topic is absolutely worth the effort.




RESEARCH ON CLERGY SEXUAL ABUSE IN THE CATHOLIC CHURCH

The Ruth Institute has conducted the most comprehensive statistical analysis of clergy sexual abuse in the Catholic Church. Our Senior Research Associate, Fr. Paul Sullins, Ph.D., produced two indepth reports. The first report showed a strong correlation between clergy sexual abuse of minors and the number of self-identified homosexuals in the Catholic clergy. The second report showed that recently ordained priests are less likely to be abusive, and less likely to have male victims than older generations of priests.

These reports have been discussed by the media in Italian, German, Spanish and Polish, and have been downloaded nearly 15,000 times. The first report has been translated into Spanish and Polish. Archbishop Carlo Maria Viganò quoted our reports in his interview with *The Washington Post*. Archbishop Viganò is the former Apostolic Nuncio to the U.S. who has been insistent that the Church "tear down the conspiracy of silence" surrounding clergy sexual abuse.

The Ruth Institute's findings can assist the Catholic Church as well as other churches and institutions as they navigate the #MeToo era.



PETITION TO MAKE THE FAMILY GREAT AGAIN

The Ruth Institute's work is built around two self-evident truths:

- Every person comes into the world as a helpless baby.
- Every person has a mother and a father.

We oppose the Sexual Revolution because it has undermined these basic human rights and victimized millions of people. In September 2019, we took advantage of a unique opportunity to publicize these important truths. We launched a petition to "Make the Family Great Again," in partnership with Life Petitions.

The project was inspired by the announcement that Secretary of State Mike Pompeo had created a Commission on Unalienable Rights. This Commission will advise the State Department on how to promote authentic human rights, especially in multinational organizations like the United Nations. The Commission is chaired by Harvard Law Professor Mary Ann Glendon, a longtime advocate of the right to life, and a former Vatican Ambassador.



Our petition urges the Commission to consider these unalienable rights:

- The right of every child to a relationship with his or her natural mother and father except for an unavoidable tragedy.
- The right of every person to know the identity of his or her biological parents.
- The right to life from conception to natural death.
- The right of families to educate their own children in their faith tradition and values, without being undermined by the state.

Too often in the past, agencies like USAID have lavished huge sums on population control in developing nations, while giving embarrassingly small amounts to projects like clean water and maternal health. The Ruth Institute is collaborating with organizations from around the world to challenge these misplaced priorities. More than 40 high-profile pro-family leaders signed our petition, including international leaders from Africa, Europe, South America and Australia, as well as North America.

VALUES VOTER SUMMIT











October 11-13, The Ruth Institute participated in the Family Research Council's Values Voter Summit in Washington, D.C., as one of more than 50 exhibitors. During this time, Dr. Morse was interviewed by EWTN's Jason Calvi on the topic of the previous night's Democratic candidate debate.

The centerpiece of the Ruth Institute's booth was the "Make the Family Great Again" petition. Participation in the 2019 Values Voter Summit allowed us to receive more petition signers among the attending leaders and activists.

We also increased our credibility and connection with some of the major pro-family organizations nationally. Last, but not least, we distributed our "Make the Family Great Again" baseball caps.

RUTH MAKING MEDIA: "THE DR. J SHOW"

"The Dr. J Show," which premiered in September, is our latest tool for building an international interfaith coalition to defend the family. Video webcasts and a YouTube channel are some of the best ways to effectively communicate in today's world. "The Dr. J Show" breaks new ground for The Ruth Institute by being a fully-produced video program, featuring music and graphics.

The core of each episode is an interview with a special guest who has expertise or experience with the Sexual Revolution. We speak plainly with researchers and experts about the documented consequences of clergy sexual abuse, abortion, same sex activity, and transgenderism. We offer encouragement and help to both those who suffer from gender dysphoria and those who care about their suffering.

Each episode also features headlines highlighting the latest research proving that pre-Sexual Revolutionary ideas on sex and morality have been correct all along. The episode ends with an "Action Item" from our guest, giving viewers something they can do to make a difference.

The weekly "Dr. J Show" is offered in both video and audio-

Rosary Around the Lake: A Local Event with National Implications




